1. Description of Contest/Participation. Contestants will guess the predetermined amount of money in the jackpot. Jackpots will vary in prize money. If the contestant correctly guesses the amount of money in the jackpot they win that amount. If they do not guess the correct amount a recorded announcement will tell them if they are too high on their guess or too low.
